



QUALIFIED WATER EFFICIENT LANDSCAPER 2010 EXAM REGISTRATION

QWEL DESIGNATION OVERVIEW

The Marin Municipal Water District is offering a self-study Qualified Water Efficient Landscaper (QWEL) exam allowing landscapers to attain QWEL designation without attending the 12 week QWEL training class. Participants **MUST** pass the QWEL exam and conduct an irrigation system audit on their own using the QWEL irrigation audit forms. For your convenience we are offering an Assisted Irrigation Audit on October 16th just before exam. See the exam registration schedule below for details. Once registered, study materials and the irrigation audit form will be emailed to you.

QWEL designation has two requirements:

1. Passing a 120 question multiple-choice exam, and;
2. Completing and passing an irrigation system audit.

In addition, continuing education units (CEU's) must be submitted annually to maintain your QWEL designation. Go to www.qwel.net for details.

EXAM SCHEDULE

The QWEL exam is on Saturday October 16, 2010 at the Indian Valley College in Novato.

NOTE: For those who need assistance completing the irrigation audit we are offering an Assisted Irrigation Audit on October 16th just before the 10:00 AM exam. If you find you need help doing the irrigation audit we encourage you to sign up for the Exam and Irrigation Audit date designated **EA1**.

If you do not need help doing the irrigation audit, sign up for the Exam Only date designated **E1**.

There are no exam fees. Parking passes can be purchased from parking permit machines located in each parking lot. MMWD will not provide parking passes.

3. Once you are registered you will receive a registration confirmation with location details. The exam study guide and the irrigation audit form will also be sent to you.

Please provide the proper Exam Registration Number when registering. **You must register by the registration deadline date.** Those not properly registered will not be allowed to sit for the exam or the assisted irrigation audit. Those who drop-in un-registered will be turned away.

Space is limited so register early to reserve your place. Registration is due by the indicated registration deadline date.
